

# Of a Regional Fire Authority

**Why South East Thurston Fire Authority is being proposed, what the Fire Authority would accomplish, and how I can find out more information regarding the Fire Authority.**

**T**he city council and the Yelm Area Fire District have been working together for several years to bring this proposal to the voters. If you have questions, take the time to get the answers so your decision can be an informed one.

1. Thurston County Fire District #4 (Rainier), Yelm Fire District #2, and the City of Yelm are seeking voter approval to form the South East Thurston Fire Authority (SETFA) on the February 9, 2010 ballot.
2. Citizens living outside the Yelm City limits are currently paying \$1.50 per \$1,000 of assessed property value. This proposition will not change the current tax collection for citizens outside the city limits of Yelm.
3. Yelm residents will be taxed the same as county residents, but will now also be able to vote for fire commissioners and vote for levy lifts. At the same time, Yelm residents will be able to have a fire department that will serve their needs. Right now residents pay city taxes and the city contracts with the local fire department. If the proposed regional fire authority passes, Yelm residents will pay the fire authority tax in their property taxes instead of paying for fire protection in their city taxes.
4. The South East Thurston Fire Authority Operations Plan provides for improved service. Service improvements include the capability to provide 24 hour staffing at the Yelm Fire Station and the Rainier Fire Station. Staffing 2 stations help to decrease response times by decreasing the size of the area they cover and provides a minimum of 5 firefighters on duty making it possible to meet National Fire Protection Agency standards that require at least 4 firefighters on a structure fire before entering a burning building.
5. By increasing the number of on duty firefighters and staffing 2 engines, the fire department can apply for a reassessment by the Washington Survey and Rating Bureau. This reassessment could result in a reduction in the insurance rating for the City of Yelm, City of Rainier, and the unincorporated area outside the cities.
6. If voters approve the RFA in February, the new South East Thurston Fire Authority (SETFA) will replace the two (2) participating fire districts on July 1, 2010 with voter approved funding to take effect January 1, 2011.

The Regional Fire Authority Planning Committee consists of three elected fire commissioners from the Yelm Fire District, the Rainier Fire District and three City of Yelm Council members. This committee prepared a written plan to form a Regional Fire Authority (RFA). The formation of the RFA was to bring all three jurisdictions together under one operating authority—S. E. Thurston Fire Authority. The measure will again be put before the voters on February 9th election. Forming a regional fire authority is a process being replicated throughout the state as a cost cutting measure, consolidating smaller fire departments into one larger fire department.

For the past few years, Yelm Fire District, Rainier Fire District, and the City of Yelm have been operating as a single fire department, but without a single taxing authority. A specific challenge of this operation is that each jurisdiction was paying a different amount for fire and emergency medical services. Three years ago, residents in the county voted in a levy lid lift which taxed themselves at a higher rate than those in the City of Yelm. The RFA request is to bring all residents under one authority and at the same cost, so that the costs of this service are shared equally across the board, just as the protection offered by this service is shared.

What we need to ensure is that all residents understand that this formation of a Regional Fire Authority (RFA) was designed to bring equality to the process of paying for and making decisions over services that are shared by all.

The RFA Planning Committee simply asks February 9th: please read carefully what you are being asked to vote on, check the facts before you vote. 🗳️

## Seconds Do Count

**In an emergency, it is very important that your address marker is visible from the road so the firefighters/EMTs can find you quicker.**

Ask yourself: 1) Can your house numbers be seen from the road? 2) Are the house numbers clearly visible on your mail box? 3) Can the numbers be read at night? 4) Can it be seen from both directions?

## Fire Department Arrives

**A**fter you have called 9-1-1, there are several things  
you can do until Emergency Responders arrive. These  
simple procedures will greatly aid the Emergency  
Responders and the patient they will treat.

- Stay calm; do not get excited. This will reassure the patient that help is on the way.
- If you determine that the patient is pulseless and non-breathing, begin cardiopulmonary resuscitation (CPR), but only if you have been trained in this life saving technique. If you have not been trained in CPR, call 911 and ask for assistance over the phone. The 911 operator can give you step by step directions.
- Make the patient as comfortable as possible.
- Gather all the medications that the patient may be taking. This will help Emergency Responders better determine the medical history of the patient.
- Move all furniture or obstacles out of the way so Emergency Responders have easy access to the patient. Make sure all pets are secure in another part of the house.
- Remember the time, this is very important. When was the last time you talked to the patient? How long has this medical condition existed? How long has the person been unconscious?
